



RULES OF COEXISTENCE

1. ALL GUESTS AND VISITORS ARE OBLIGED TO COMPLY WITH THESE RULES OF COEXISTENCE, AS WELL AS THE SPECIFIC RULES OF EACH AREA (LAUNDRY AND PUBLIC TOILETS). THE COMPLETE TEXT OF THE RULES OF COEXISTENCE AND THE INTERNAL REGULATIONS HAVE BEEN GIVEN TO YOU TOGETHER WITH THE CONTRACT OF STAY.
2. THE TIME OF ENTRY TO THE CAMPSITE WILL BE BETWEEN 12:00 AND 20:00 HOURS. THE TIME OF DEPARTURE MUST BE BETWEEN 9:00 AND 12:00 HOURS.
3. THE CIRCULATION OF VEHICLES IS PROHIBITED BETWEEN 22:00 AND 9:00 HOURS.
4. THE CIRCULATION INSIDE THE CAMPSITE IS LIMITED TO 10 KM/H. PLEASE RESPECT THE SIGNS INDICATING THE DIRECTION OF THE ROADS.
5. RESPECT THE LIMITS OF YOUR PLOT. WE RECOMMEND PARKING YOUR VEHICLE AT ABOUT 50 CM. FROM THE SIDE BOUNDARY. THIS WAY YOU WILL BE ABLE TO OPEN THE WINDOWS WITHOUT PROBLEMS AND ACCESS THE SIDES OF YOUR VEHICLE. REGARDING THE ORIENTATION OF THE VEHICLE, FOLLOW THE INDICATIONS OF THE STAFF OF PARAISO CAMPER. IN CASE OF NOT HAVING THESE INDICATIONS, KEEP THE SAME ORIENTATION AS THE REST OF THE VEHICLES.
6. IT IS FORBIDDEN TO ACCESS ANY PLOT OTHER THAN YOUR OWN, UNLESS EXPRESSLY AUTHORIZED BY THE OCCUPANT OF THE PLOT OR BY THE RECEPTION STAFF.
7. RESPECT THE HOURS OF REST (FROM 14:00 TO 16:00) AND ABSOLUTE SILENCE (FROM 22:00 TO 9:00). IN THE MONTHS OF MAY, JUNE, JULY, AUGUST AND SEPTEMBER, THE HOURS OF ABSOLUTE SILENCE SHALL BE FROM 23:00 TO 9:00.

8. PARENTS WILL BE RESPONSIBLE AT ALL TIMES AND PLACES FOR THEIR CHILDREN.
9. ANY ACTIVITY THAT MAY DISTURB OTHER USERS IS PROHIBITED: HIGH VOLUME ON ANY ELECTRONIC DEVICE, CYCLING THROUGH THE AREA ON A BICYCLE, BALL GAMES AND ANY NOISY OR ANNOYING GAMES.
10. PETS ARE ALLOWED, BUT ALWAYS LEASHED AND CONTROLLED BY THEIR OWNERS. AVOID LETTING THEM RELIEVE THEMSELVES INSIDE THE CAMPSITE. IF IT HAS NOT BEEN AVOIDED, IT IS MANDATORY TO PICK UP THE EXCREMENTS AND CLEAN THE AREA. IN CASE OF NOT PICKING THEM UP AND/OR CLEANING THE AFFECTED AREA, THE OWNER OF THE ANIMAL WILL HAVE TO PAY A PENALTY OF FIFTY EUROS (50 €).
11. ORGANIC WASTE WILL BE DEPOSITED IN THE CONTAINERS LOCATED ON THE STREET ABOVE THE CAMPSITE, ABOUT 50 METERS FROM THE ENTRANCE OF THE CAMPSITE. FOR THE RECYCLING OF PLASTICS, GLASS AND PAPER, THERE ARE CONTAINERS IN THE STREET BELOW THE CAMPSITE.
12. PARAISO CAMPER IS NOT RESPONSIBLE FOR POSSIBLE THEFTS OR ROBBERIES INSIDE THE CAMPSITE.
13. BARBECUES WITH FIRE (CHARCOAL OR FIREWOOD) ARE PROHIBITED. ONLY GAS OR ELECTRIC BARBECUES ARE ALLOWED.
14. IT IS FORBIDDEN TO FEED WILD ANIMALS (CATS, PIGEONS, DOVES, TURTLEDOVES, ETC.).
15. THE INSTALLATION OF TENTS FOR USE AS LODGING IS PROHIBITED.
16. IN CASE OF DISAGREEMENT WITH ANOTHER USER, AVOID CONFRONTATION. COMMUNICATE THE PROBLEM AT RECEPTION AND WE WILL FIND THE BEST SOLUTION FOR EVERYONE.
17. IT IS EXPRESSLY FORBIDDEN THE INSTALLATION BY THE CLIENTS OF ELEMENTS THAT DO NOT CORRESPOND TO THE TEMPORARY, PROPER AND USUAL USE OF THE CAMPSITES. FOR EXAMPLE: FLOORS, FENCES, SINKS, ELECTRICAL APPLIANCES...
